Should the memorial not comply in full with Woodvale Cemetery’s rules and regulations, the memorial must be brought into conformity or be removed by the monument dealer at the request of the cemetery management within (3) three days of the request.

**Note:** All monument dealers must check in at office before 3:00 P.M. with a list of memorials that are being delivered and/or set. Memorials can only be set Monday – Friday 8:00 A.M. – 4:30 P.M.
